- ➤ Concerns over sanding were brought to the attention of the council. The department of transportation has informed the town that they do not have the resources to deliver the sand and that a Site-Specific Safety Plan must be completed to enter the premises to get sand. This document is 35 pages and requires a great deal of work. Council had a discussion, and it was determined that over the summer months, a building would be constructed to store sand and the truck for the purpose of ensuring that the town has the materials required to properly service roads.
